**Minutes**

**Call to Order at 3:18 by Mrs. Mistry**

Approve Minutes from 11/14/22. Minutes were approved by Mr. Baayoun and seconded by Mrs. Grossi. No corrections. Motion carried.

Chairperson Meeting Report (1/17/23, 2/21/23) - Mrs. Stenroos went over the district notes from the last two chairperson meetings. The next meeting tomorrow was canceled and will not be rescheduled. The next meeting is set to take place April 27.

New System for SPSA - Mrs. Stenroos showed the committee Document Tracking Systems. She went through the overlap and what items are the same. Note - we will still have a reading, math and school climate goal. However, we will now also have a science goal.

ELAC Feedback - Ms. Camara - Assistant Principal- joined us for the meeting. She discussed the purpose of ELAC, what they do, how students qualify and reclassify. Additionally, she was able to share their two recommendations that they had for site council - 1. they would like the school to offer a family night for EL students to provide information and a family engagement event for families to get to know each other. 2. They would like the school to seek out volunteers who speak different languages to help students in the home language improve in English.

Old Goals - We reviewed the old goals that SR had in the 22/23 SPSA. There is an ELA goal where all students will meet or exceed the end of the year grade level expectations in ELA as measured by district benchmarks in TK-2 and CAASPP in grades 3-6. In TK-2, the focus is on phonemic awareness, phonics, decoding and fluency. In grades 3-6, the focus shifts to comprehension and the use of details in order to analyze text. In math, we had a goal of all students will meet or exceed end of the year grade level

expectations in the area of numbers and operations in base -ten as measured by district benchmarks in TK-2 and on CAASPP in grades 3-6. Our school climate goal read that in order to further develop our school-wide buddy system where upper grade students partner with primary buddies for cross-age learning support and team completed projects which will result in increased number of students indicating their connection to

school on site create surveys and the 5th grade California Healthy Kids Survey.

New Goals Feedback - Team is satisfied with the ELA and math goals. We discussed that we were waiting to hear from the district if we will continue to use the language all students or if we will set a percentage goal. We would like to really focus on PBIS and attendance for our school climate goal. For science, we will be writing a similar goal to ELA and math using the CAST as measurement.
